

Reserve Preferencing Training Course System Assignment Logic

The Reserve Preferencing system uses a third-party program to assign Reserves based on their input preference criteria, and consideration of their days of availability, TMAC and other legalities. The examples below are simple scenarios to help understand basic concepts. There are no legality issues to consider in these scenarios beyond the number of days the Flight Attendant is available.

Keep in mind that each scenario may not be applicable at the end of the month where coverage is typically a concern and when Reserve assignments are accomplished observing Section 8.H.6 and 8.H.8.d. of the Contract. Specifically, when assignments are made that transition from one month to the next, the Reserve Preferencing system will consider what is "least disruptive" to activity in the new month. As a result of this coverage component, there will be times at the end of the month where certain preferences may not be considered.

PRINCIPLE 1

Reserves are considered for assignments in day-classification order (i.e. 1-day, 2-day, 3-day, 4-or more day.

Section 8.D.6.a. provides: "...Reserves within each group of days of availability ("day classification") shall be considered for Open assignments matching the corresponding number of days of availability. A Reserve who has submitted a preference request(s) shall be assigned in time accrued order to the first open assignment that matches a request."

Example

This is the CLE Reserve Time for the 8th of April - there is only a 1-day trip:

Scenario 1.1

Flight Attendant Marcus enters a preference for a 2-day trip – the other Flight Attendants do not enter any preferences. However, Marcus is a 3-day Reserve.

Because there is a 2-day Reserve (S. Carter) legal and available to fly the 2-day trip, she/he will be assigned pairing V0644 regardless of the preference entered by Marcus. The remaining Reserves will be assigned to Ready Reserve or Released based on the needs of the operation.

PRINCIPLE 2

Within day-classification, Reserve preferences are assigned in time-accrued (TMAC) order.

Section 8.D.6.b. provides: "...If two or more Reserves in the same day classification indicate the same preference, the assignment will be made to the Reserve with the least time accrued. If they have the same time accrued, the assignment will be made to the most senior Reserve with the preference."

Example

The following is the LHR Reserve Time for the 23rd of April. There is only a 2-day trip – pairing U5100 – with a layover in IAD:

The following 5 reserves are available for assignment during the Reserve Preferencing process, however only the 2-day Reserves will be considered (Pitchely, Eli, Darjeeling and McKee) for the assignment:

Scenario 2.1

Both Flight Attendants Eli and Darjeeling preference pairing U5100 – because Eli, of the two Flight Attendants who have expressed a preference has less TMAC, will be assigned the pairing U5100. The remaining Reserves will be assigned to Ready Reserve or Released based on the needs of the operation.

Scenario 2.2

Only Flight Attendant Darjeeling enters a preference (IAD layover). The other Reserves do not enter any preferences. Despite the fact that Darjeeling has the most time accrued (TMAC) and is the third of the 2-day Reserves, Darjeeling will be assigned pairing U5100. The remaining Reserves will be assigned to Ready Reserve or Released based on the needs of the operation.

Scenario 2.3

No Flight Attendant has any preference on file; since all of the 2-day Reserves are legal and available, Flight Attendant Pitchely will be assigned the pairing as she has the least TMAC (or appears first on the list in TMAC order.)

PRINCIPLE 3

When there are more trips than Reserves available, the Company will determine which trips will be left uncovered during the Reserve Preferencing process. In general, at the time the system is assigning the trips, the earliest check-ins will be assigned first.

Section 8.D.8. provides: "...When the number of open assignments is greater than the number of Reserves, the Company shall designate those assignments that shall be left uncovered."

Example

The following is the SFO Reserve Time for May 6th. There are four open 3-day pairings:

Scenario 3.1

Both 3-day Reserves preference pairing F1122, which is the latest check-in at 2000. In a situation where it is determined pairing F1A2P (FA02) & F1122 will be left uncovered, this preference will not be honored and the system will assign the first 2 trips leaving pairings F1A2P (FA02) & F1122 in Open Time.
